We are pleased to announce that the Gloucester Township Day Scholarship Committee will again award scholarships to high school seniors *who are residents of Gloucester Township*, regardless of the high school they attend. Fortunately, fundraising has improved, and we will be able to award 50 scholarships in the amount of \$1,000.00 each this spring.

Specific eligibility criteria concerning residency, SAT/ACT scores, and GPA/class rank are listed on the application itself. Additional rules and regulations are provided on the reverse side.

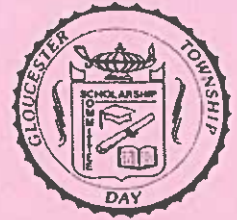

# Gloucester Township Day Scholarship Committee

## Scholarship Application



The Gloucester Township Day Scholarship Committee will award fifty (50) scholarships in the amount of \$1,000.00 each to be applied toward expenses at an accredited college or university. To be eligible, a student must meet the following criteria:

- I. Be a senior in high school and reside presently, and for at least the last three years, in Gloucester Township.
- II. Be accepted at an accredited college or university.
- III. Earn a score of at least 800 on the combined *Math* and the *Evidenced-Based Reading/Writing* portions of the SAT or Earn a Composite Score of at least 17 on the ACT.
- IV. Rank in the top 50% of his/her graduating class or achieve a Grade Point Average of at least 2.5 (on a 4.0 scale).

*Special consideration will be given to classified college-bound students who do not meet criterion III above.*

## RULES AND REGULATIONS

Only those students who apply by the stated deadline will be considered for the scholarship.

The highest READING the highest MATH scores achieved by the students will be used to determine the official combined S.A.T. score for the purposes of this scholarship. In other words, scores from different test dates will be combined to produce the highest possible total score. Only SAT Scores achieved on tests administered up to and including December 2, 2023 can be included. If SAT scores are pending, the student and/or counselor should so indicate.

The highest Composite score achieved by students will be used to determine the official ACT Composite score for the purposes of this scholarship. Only ACT Scores achieved on tests administered up to and including February 10, 2024 can be included. If ACT scores are pending, the student and/or counselor should so indicate.

Grade Point Average and rank in class as of the end of the junior year will be considered as the official G.P.A. and class rank for the purpose of this scholarship.

Scholarships will be awarded by lottery from the pool of applicants who meet the established criteria.

- Each eligible student will be assigned a number by the Scholarship Committee.
- A list of eligible students showing the number assigned to each student will be prepared by the Committee and utilized during the Lottery Drawing.
- The number shown on this list will be official.

No other criteria or qualifications except those stated here and on the application itself will be considered.

Winners will be notified by May 1, 2024 and the scholarships will be announced to the public on Gloucester Township Day.

Upon notification, the winning students must provide proof of residency and acceptance at an accredited college or university. Winners must furnish requested information in compliance with deadlines established by the Scholarship Committee. If not, the scholarship will be awarded to an alternate.

Scholarship recipients must graduate from high school by August, 2024 and must be enrolled in a college or university by September, 2024. If not, the scholarship will be awarded to an alternate.

Unless other specific arrangements are made in advance, the scholarship will be paid directly to the college or university which the student will attend.
